RE: BTTC

Dear Mr. Ye:

I represent Jerry Li, Steve Ma, Chris Pham and Howard Grossman in connection with Bellevue Table Tennis Club ("BTTC"). As you know, they were all BTTC board members when you incorporated the organization on November 9, 2014. I write to request that you cease acting on behalf of BTTC immediately and return control of the organization to my clients.

Ever since the incorporation in November 2014, you have been taking unauthorized steps to control BTTC and at the same time misrepresenting to the Office of Secretary of State about the directorship or governorship of the organization. Specifically, you have:

- included your daughter Sophie Ye as one of the initial directors without board approval;
- added your son David Ye in 2017 to the board without proper board approval;
- removed Chris Pham and Steve Ma in 2019 without proper board approval;
- removed Jerry Li and Howard Grossman recently without proper board approval;
- removed BTTC members' voting rights in June 2016 without proper board approval;
- changed the officers without proper board approval;
- added new board members, namely, Xiaozhen Li, Zheng Wang, Bin Chen and Youming Wu without proper board approval;
- accomplished all of the above without complying with the notice requirements under RCW 24.03A.015, RCW 24.03A.530(2) and BTTC bylaws;

■ together with Sophie Ye and Davie Ye have breached their fiduciary duty as directors by controlling the organization as the three of you clearly have a conflict of interest. A majority-related board is specifically disallowed by IRS since it affects quorum.

My clients are ready to provide affidavits testifying that they had never received notices, in one form or the other, from you or Sophie Ye regarding BTTC board meetings since November 2014. Nor had they ever received any meeting minutes or notifications regarding any board actions or decisions. Should you disagree, please provide me all board meeting minutes since the incorporation of BTTC and proof of notices of all board meetings by the end of next week or September 9, 2022.

If you do not respond by September 9, 2022 or fail to provide board meeting minutes and proof of notices of board meetings, I will have no choice but to report you to the Washington State Attorney General Office and to consider taking legal action against you and Sophie Ye for breaching fiduciary duty as directors of the board, unless you agree to stop acting on behalf of BTTC and to walk away from the board immediately.

I look forward to your cooperation in the resolution of this matter.
